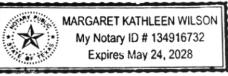

TRAILS AT MONTEREY COMMUNITY DEVELOPMENT DISTRICT REGULAR BOARD MEETING FEBRUARY 25, 2025

A. CALL TO ORDER

District Manager, Nancy Nguyen called the Trails at Monterey Community Development District (the "District") Regular Board Meeting of February 25, 2025, to order at 6:37 p.m. in the Comfort Suites Miami-Kendall Conference Room B located at 3901 SW 117th Avenue, Miami, Florida 33175.

B. PROOF OF PUBLICATION

Ms. Nguyen presented proof of publication that notice of the Regular Board Meeting had been published in the *Miami Herald* on December 2, 2024, as part of the District's *Revised* Fiscal Year 2024/2025 Regular Meeting Schedule, as legally required.

C. ESTABLISH A QUORUM

Ms. Nguyen stated that the attendance of Chairman Juan Sanhueza, Vice Chairman Sebastian Hale (who arrived at 6:39 p.m.) and Supervisors Katherine Castineiras, Jorge Garcia Hernandez, and Laura Alvarez (via conference call) constituted a quorum and it was in order to proceed with the meeting.

Staff in attendance included: District Manager Nancy Nguyen of Special District Services, Inc., and General Counsel Gregory George of Billing, Cochran, Lyles, Mauro & Ramsey, P.A.

D. CONSIDER RESOLUTION NO. 2025-01 – DECLARING VACANCIES (SEATS 1, 2, AND 5)

Ms. Nguyen presented Resolution No. 2025-01, entitled:

RESOLUTION NO. 2025-01

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TRAILS AT MONTEREY COMMUNITY DEVELOPMENT DISTRICT DECLARING VACANCIES ON THE BOARD OF SUPERVISORS PURSUANT TO SECTION 190.006(3)(b), FLORIDA STATUTES; AND PROVIDING AN EFFECTIVE DATE.

Ms. Nguyen read the title of the resolution into the record. She provided an explanation for the document and advised that the 4-year terms of office for Seat 1 (currently held by Katherine Castineiras), Seat 2 (currently held by Juan Sanhueza), and Seat 5 (currently held by Jorge Garcia Hernandez) expired in November 2024. She further explained that no elector qualified for Seat 1, Seat 2, or Seat 5 to be filled in the General Election. Pursuant to Section 190.006(3)(b), Florida Statutes, the District is required to declare the seats to be filled by the election to which no qualified elector has qualified as vacant and to appoint a qualified elector to fill each such vacancy within ninety (90) days of the second Tuesday following the General Election. Until such appointment, the incumbent board member in such seat shall remain in office.

A **MOTION** was made by Mr. Hale, seconded by Mr. Sanhueza and unanimously passed to declare Seat 1, Seat 2, and Seat 5 as vacant effective November 19, 2024 and further authorizing incumbent board members in these seats to remain in office until the appointment of a qualified elector to such seats.

E. DISCUSSION REGARDING VACANCIES AND APPOINTMENTS TO FILL VACANCIES

Ms. Nguyen stated that vacancies had been declared in Seats 1, 2, and 5, effective as of the second Tuesday of November (November 19, 2024) following the November General Election (November 5, 2024). Pursuant to Section 190.006(3)(b), Florida Statutes, incumbents (holdover Board Members) will serve no longer than ninety (90) days (from November 19, 2024) or until appointments to the vacancies have been made. A discussion ensued after which:

A **MOTION** was made by Ms. Castineiras, seconded by Mr. Garcia Hernandez and unanimously passed to appoint Katherine Castineiras to Seat 1, Juan Sanhueza to Seat 2, and Jorge Garcia Hernandez to Seat 5; and such terms of office will expire in November 2028.

F. ADMINISTER OATH OF OFFICE AND REVIEW NEW BOARD MEMBER DUTIES AND RESPONSIBILITIES

Ms. Nguyen, Notary Public in the State of Florida, administered the Oath of Office to Ms. Castineiras, Mr. Sanhueza, and Mr. Garcia Hernandez. In addition, Ms. Nguyen advised that the duties and responsibilities as Board members remain the same.

G. ELECTION OF OFFICERS

As a result of the changes to the Board of the District, Ms. Nguyen recommended that re-election of the District's Officers take place. She provided the following slate of names for election:

- Chairperson Juan Sanhueza
- Vice Chairperson Sebastian Hale
- Secretary/Treasurer Nancy Nguyen
- Assistant Secretaries Katherine Castineiras, Jorge Garcia Hernandez, Laura Alvarez, Armando Silva and Gloria Perez

A **MOTION** was made by Ms. Castineiras, seconded by Mr. Garcia Hernandez and passed unanimously to *elect* the District's Officers, as listed above.

H. ADDITIONS OR DELETIONS TO AGENDA

There were no additions or deletions to the agenda.

I. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

J. APPROVAL OF MINUTES

1. OCTOBER 15, 2024, Regular Board Meeting

The minutes of the October 15, 2024, Regular Board Meeting were presented for approval.

There being no changes, a **MOTION** was made by Ms. Castineiras, seconded by Mr. Hale and unanimously passed approving the minutes of the October 15, 2024, Regular Board Meeting, as presented.

K. OLD BUSINESS

1. Staff Report, as Required

There was no old business to discuss at this time.

L. NEW BUSINESS

1. Consider Resolution No. 2025-02 – Adopting a Fiscal Year 2025/2026 Proposed Budget

Ms. Nguyen presented Resolution No. 2025-02, entitled:

RESOLUTION NO. 2025-02

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TRAILS AT MONTEREY COMMUNITY DEVELOPMENT DISTRICT APPROVING A PROPOSED BUDGET FOR FISCAL YEAR 2025/2026; AND PROVIDING AN EFFECTIVE DATE.

Ms. Nguyen read the title of the resolution into the record and explained that the proposed 2025/2026 fiscal year budget would be balanced by designating a carryover of approximately \$26,783 from the projected fund balance as of September 30, 2025. She further explained that the project fund balance as of September 30, 2025 is approximately \$180,000. Ms. Nguyen advised that since the overall proposed assessments were not increasing in the fiscal year 2025/2026, letters to the residents would not be required. Furthermore, Ms. Nguyen stated as part of Resolution No. 2025-02, the Board must set a date for the public hearing to adopt the fiscal year 2025/2026 final budget and assessment roll.

Ms. Nguyen explained that at the direction of the Board, she did not include a budget line for lake bank restoration. The Board agreed with Ms. Nguyen's actions. Mr. Garcia Hernandez stated that several District residents have conveyed to him their desire to dissolve the District. Mr. Garcia Hernadez requested that the maintenance contracts of the District be reviewed to determine if there is a possibility of lowering the District's expenses and in turn increasing the District's fund balance. Ms. Nguyen stated that she will request proposals for aquatic maintenance and landscaping. A discussion ensued after which:

A **MOTION** was made by Ms. Castineiras, seconded by Mr. Garcia Hernandez and unanimously passed to approve and adopt Resolution No. 2025-02, *as presented*, setting the public hearing to adopt the fiscal year 2025/2026 final budget and assessments for <u>April 29, 2025, at 6:30 p.m.</u> in the Comfort Suites Miami-Kendall Conference Room located at 3901 SW 117th Avenue, Miami, Florida 33175; and further authorizes publication/notice of the budget public hearing, as required by law.

2. Consider Resolution No. 2025-03 – Registered Agent Change

Ms. Nguyen presented Resolution No. 2025-03, entitled:

RESOLUTION 2025-03

A RESOLUTION OF THE TRAILS AT MONTEREY COMMUNITY DEVELOPMENT DISTRICT DESIGNATING MICHAEL J. PAWELCZYK AS THE DISTRICT'S REGISTERED AGENT AND DESIGNATING THE

OFFICE OF BILLING, COCHRAN, LYLES, MAURO & RAMSEY, P.A. AS THE REGISTERED OFFICE

Mr. George explained that Florida Statutes requires that the District designate a registered office and registered agent for the purpose of accepting service of process, notice, or demand that is required by law to be served upon the District. He further explained that it is necessary to designate a new registered agent and update the business address of the registered office. A discussion ensued, after which:

A **MOTION** was made by Mr. Hale, seconded by Mr. Garcia Hernandez and unanimously passed designating Michael J. Pawelczyk as the Trails at Monterey Community Development District registered agent, and designating the registered office at Billing, Cochran, Lyles, Mauro & Ramsey, P.A., 515 East Las Olas Boulevard, Suite 600, Fort Lauderdale, Florida 33301.

M. ADMINISTRATIVE MATTERS

1. Staff Report, as Required

There were no administrative matters to discuss at this time.

N. BOARD MEMBER/STAFF CLOSING COMMENTS

Mr. Garcia Hernandez asked if there is a way of increasing the debt service assessment amount being collected in order to pay off the District's debt sooner than the maturity date of May 2033. It was explained to Mr. Garcia Hernandez that District's Special Assessment Methodology Report sets the maximum annual debt service assessment allowed per residential unit. Ms. Nguyen stated that she will review the Special Assessment Methodology Report to determine if the maximum annual debt service assessment is being collected. There were no additional Board Member closing comments.

Ms. Nguyen reminded the Board that the Final Budget Public Hearing is scheduled for April 29th at the Comfort Suite Miami-Kendall venue.

O. ADJOURNMENT

There being no further business to come before the Board, a **MOTION** was made by Ms. Castineiras, seconded by Mr. Garcia Hernandez adjourning the meeting at 7:32 p.m. The **MOTION** carried unanimously.

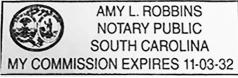
